Description of Facility	Thompson Metal Fab, Inc. operates a metal fabrication and coating facility that specializes in large structural steel projects. The facility occupies work bays in Building 40 of the Columbia Business Park. Other building locations and outdoor areas are occupied on a temporary basis in support of specific projects.
Source Designation	Title V Opt-out. This facility is a stationary source that would be subject to the Operating Permit Program if a federally enforceable emission limit was not in place. Facility emissions are limited to less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.
Purpose of Application	SWCAA has received a permit application for replacement of an existing plasma cutter at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information.
