Source Designation	Major/PSD The facility is subject to review under WAC 173-400-700 as a stationary source. Facility emissions will be greater than the applicable criteria pollutant emission threshold defined in SWCAA 400-030 for a "major stationary source". For this facility the applicable emission threshold is 250 tons per year of any single criteria air pollutant.
Purpose of Application	SWCAA has received a permit application for installation of six reciprocating internal combustion engines burning landfill gas to drive electric generators to produce electricity for sale. A Prevention of Significant Deterioration (PSD) permit application has been submitted to the Washington Department of Ecology for this project. SWCAA will be reviewing those pollutants not addressed by the PSD permit application. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
