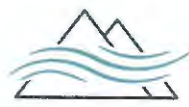

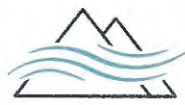

None at this time, other than the application for air permit authorization of the new equipment / activities. The Vancouver Facility's existing Air Discharge Permit will need to be revised to incorporate the Project's emissions sources / activities.

SWCAA air permit authorization. It is currently unknown what local permits will be required (if any).

The Project is essentially a replacement project and involves: a) the replacement of a mechanical railcar corn unloading system (drag chain conveyors, bucket elevators, chutes) with a pneumatic unloading system (vacuum and compressed air), b) the replacement of (3) existing corn storage silos with (3) new silos, and c) the replacement of the pneumatic conveyance piping which transfers corn from the silos to the existing production area. There will be no change to existing processes.

The Project is at the site of Frito-Lay's existing snack food manufacturing facility in Vancouver, WA. The new railcar unloading area and storage silos will be located approximately 140 ft. to the west of the existing location.

The property is essentially flat with a gradual slope to the detention pond at the west end of the site.

The composition of the site's soils has not changed. A minimal amount of soils will be impacted (see 1e below). These soils underlie existing paved areas of the site.

There will be minor saw-cut areas for the purpose of installing a new silo pad and transfer support structures for the new pneumatic rail car unloading system. The combined saw-cut area includes approximately 6300 sq. ft.

Minimal risk. "Saw-cut" areas are surrounded by existing pavement.

100%; no change. The affected areas are already paved.

The contractor will develop an erosion and sediment control plan if required for the affected areas. Construction will not begin until the control features are in place.

Corn particulates; <1 ton per year. All new operations will be served by high efficiency dust collectors.

As indicated in 2a, all corn transfer operations will be served by high efficiency dust collectors. All dust collector emission rates will meet SWCAA's BACT requirement for bulk material transfer activities, i.e., ≤ 0.005 gr/scf.

There are (2) stormwater retention ponds located onsite. Vancouver Lake is located approximately 4500 ft. northwest of the site. The Columbia River is located approximately 1.5 mi. southwest of the site.
