Affected Facility	Lewis River Hydroelectric Projects PacifiCorp Hydro Resources 105 Merwin Village Court Ariel, WA 98603
Description of Facility	PacifiCorp operates an engine at the Swift Forest Campgrounds which is used for powering well water pumps since the campground is not connected to municipal power. PacifiCorp also operates several emergency generators and an ozone generation plant, which are covered under the same permit.
Source Designation	Minor The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions will be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.
Purpose of Application	SWCAA has received a permit application for replacement of a generator at the Swift Forest Campground with two smaller generators. The existing generator is used to power well water pumps, and the replacements will be used for the same purpose. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information.
