Affected Facility	Vancouver Clinic Lab 12019 NE 99 th Street, Vancouver, WA 98682		
Description of Facility	Vancouver Clinic operates eleven multispecialty medical clinics in Clark County. The proposed facility is a new clinical/pathology laboratory that will support existing clinic operations.		
Source Designation	<u>Minor.</u> The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions will be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.		
Purpose of Application	SWCAA has received a permit application for installation of new hot water boilers, a hot water heater and an emergency generator at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
