Affected Facility	ePac Portland, LLC 18110 SE 34 <sup>th</sup> Street, Vancouver, WA 98683		
Description of Facility	ePac proposes to install a new flexible packaging printing operation at an existing facility.		
Source Designation	<u>Minor.</u> The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are expected to be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.		
Purpose of Application	SWCAA has received a permit application for installation of new digital printing presses and a solventless laminator at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.		
Affected Pollutants	The proposed permitting action is expected to impact emissions of the following pollutants: VOC, ozone, HAPs, and TAPs
