The facility occupies work bays in Building 40 of the Columbia Business Park. Other building locations and outdoor areas are occupied on a temporary basis in support of specific projects.
Source Designation	<u>Title V Opt-out.</u> This facility is a stationary source that would be subject to the Operating Permit Program if a federally enforceable emission limit was not in place.
