Affected Facility	USNR 1984 Schurman Way Woodland, WA 98674		
Description of Facility	United States Natural Resources (USNR) repairs, reconfigures and manufactures saw mill log shaping and cutting equipment.		
Source Designation	<u>Minor</u> The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions will be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.		
Purpose of Application	SWCAA has received a permit application to allow for the replacement of an existing paint booth heater. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information.		
Affected Pollutants	The proposed permitting action is expected to impact emissions of the following pollutants: Nitrogen Oxides (NO _x), Carbon Monoxide (CO), Volatile Organic Compounds (VOC), Sulfur Dioxide (SO ₂), Particulate Matter (PM), Hazardous Air Pollutants (HAPs) and Toxic Air Pollutants (TAPs)		
Public Comment Period	No public comment period for the draft permit is currently scheduled. A 30-day public comment period for the draft permit may be provided upon written request pursuant to SWCAA 400-171(1).
