Affected Facility	Weyerhaeuser Hardwoods - Centralia 3000 Galvin Road, Centralia, WA 98531		
Description of Facility	Weyerhaeuser Hardwoods operates a green timber sawmill in Centralia, Washington. The sawmill receives raw hardwood timber and processes the wood into lumber. A significant portion of the lumber processed in the mill is dried in onsite lumber kilns.		
Source Designation	<u>Minor</u> . The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.		
Purpose of Application	SWCAA has received a permit application for replacement of a boiler baghouse at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
