Affected Facility	Stericycle 830 Westlake Ave, Morton, Washington 98356
Description of Facility	Stericycle operates a medical waste sterilization facility for disposable linens, gowns, drapes, hard plastics, sharps, and similar single-use materials. No radioactive wastes or hazardous materials are accepted. Stericycle currently operates an electro-thermal deactivation process and two steam autoclaves at this facility. Steam for the autoclaves is provided by a propane-fired boiler.
Source Designation	Minor. The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions will be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.
Purpose of Application	SWCAA has received a permit application for burner replacement in an existing process boiler at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
