Affected Facility	Musket Centralia Terminal 3712 Northpark Drive, Centralia, WA 98531	
Description of Facility	Musket Corporation operates a diesel exhaust fluid (DEF) terminal at the above location. Onsite processes include a water treatment system, clean water holding tanks, inline blending skid, finished product tanks, finished product packaging and bulk off-loading, urea railcar offload, and a diesel-fired process boiler.	
Source Designation	<u>Minor</u> . The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions will be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for installation of a diesel-fired process boiler at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
