Affected Facility	Centralia High School – 813 Eshom Road, Centralia, WA 98531 Centralia Middle School – 901 Johnson Road, Centralia, WA 98531		
Description of Facility	Centralia School District is a primary public education provider serving Centralia, Washington. Centralia School District currently has multiple facilities registered with SWCAA.		
Source Designation	<u>Natural Minor</u> . The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.		
Purpose of Application	SWCAA has received a permit application for replacement of an emergency generator and hot water heaters at the above described facilities. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
