Notice to the public is hereby given that the Southwest Clean Air Agency (SWCAA) is providing a 30 day public comment period for the preliminary determination to issue Air Discharge Permit 16-3204 to Northwest Innovation Works Kalama (NWIWK). This preliminary determination approves installation of a methanol production facility to be located at 222 Tradewinds Road in Kalama, Cowlitz County, Washington. The approved facility is a new source subject to both local and federal emission standards. Approved equipment instandards. proved facility is a new source subject to both local and federal emission standards. Approved equipment includes combustion turbines, process boilers/heaters, chemical process units, bulk storage tanks, and a new marine vessel loading terminal. Combustion emissions will be minimized through the use of good combustion practices, low sulfur fuel, low emission combustion technology, and catalytic control systems. Process emissions will be limited through the use of process enclosure, high temperature combustion, and high efficiency wet scrubbers. SWCAA requests that written comments be submitted within thirty (30) days of the date of publication. By rule, SWCAA nay only address comments specific to the proposed permitting action.
