Notice to the public is hereby given that the Southwest Air Pollution Control Authority (SWAPCA) has made a preliminary determination to issue Order of Approval number 98-2091 to American Cabinet Concepts, Inc. for approval of a spray booth and baghouse operation at their existing relocated facility at 128 Industrial Way, Longview, Cowlitz County, Washington. A Determination of Nonsignificance (DNS) has been made in accordance with the State Environmental Policy Act (SEPA) regarding this activity. Emission limits have been established to limit visible discharge to the atmosphere to the equivalent of zero percent opacity, not to exceed 3.5 tons/year of volatile organic compounds, and 1.0 tons/year of particulate matter. The public has an opportunity to review and comment on the preliminary Order of Approval. This preliminary Order of Approval will be made available in other media, if necessary. All written or oral comments must be received by SWAPCA within 30 days after this publication. Final action by SWAPCA to approve, modify, or deny the proposal will be taken within 10 days after the close of the comment period. If there is a demonstrated significant public interest, a public hearing may be held with the required 30 day notification.
