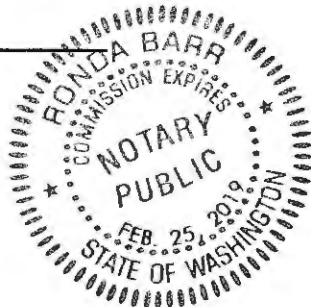
Sutter Metals is seeking coverage under the Washington State Department of Ecology's NPDES General Permit for Stormwater Discharges Associated with Industrial Activities.

Notice to the public is hereby given that the Southwest Clean Air Agency (SWCAA) is providing a 30 day public comment period for the preliminary determination to issue Air Discharge Permit 17-3246 to Puget Sound Energy. This preliminary determination approves installation of new equipment at the Jackson Prairie natural gas storage facility located at 239 Zandecki Road in Chehalis, Lewis County, Washington. The proposed project will replace an existing thermal oxidizer and line heater with new units of similar size and configuration. The replacement is a maintenance action made necessary by aging and degradation of the existing units. No change in operation is proposed as part of this project. No other equipment modifications will be made as part of this project.

Copies of the preliminary Air Discharge Permit and associated Technical Support Document are available for review at 11815 NE 99th Street, Suite 1294, Vancouver, Washington, Monday through Friday from 7:00 a.m. to 5:30 p.m. Electronic copies are available for review in the permit section of SWCAA's internet website (www.swcleanair.org/permits/public_comments.asp). This material will be made available in other media, if necessary. All written or oral comments must be received by SWCAA within thirty (30) days after the date of publication. Final action by SWCAA to approve, modify, or deny the proposal will be taken within ten (10) days after the close of the comment period. If there is a demonstrated significant public interest, a public meeting may be held at the close of the public comment period.
