There will also be trenching for underground utility lines (propane and electrical power). The trenching will be approximately 50'.

Proposed measures to reduce or control erosion, or other impacts to the earth, if any: Gravel will be added to reduce or control erosion. Exposed soil will be reseeded and covered with chopped / blown straw or hay.

Emissions to the air during construction will be minimal and from a tractor during construction. During operation following completion, the ThermtecG-30-P will be fired by propane and will be cremating animal remains which will lead to emmissions. Approximate quanities of emmissions are unknown at this time.
