SEPA Determination of Non-Significance

Associated Permit #0000091-006

Project Name: PNW Metal Recycling, Inc. Shredder Addition

Description of proposal:

The applicant PNW Metal Recycling Inc., proposes the addition of a 25,000 square foot metal shredder and sorting system on an existing 25.02 acre industrial metal recycling facility located at 100 Paper Way, Longview (Parcel #616140106). The recycling center was approved under SEPA DNS #18-04-2576 and Planning Clearance # 18-04-2576. This determination is to address the proposed 25,000 square foot metal shredder and sorting system. Industrial Stormwater General Permit has already been issued by the Department of Ecology, and an Air Discharge Permit (#21-3500) was issued by SWCAA on January 25, 2022. Impervious surface will not expand from the impervious surface approved in Planning Clearance #18-04-2576. No critical areas are present on site or will be impacted by this proposal. The project will add approximately 30 employees to the facility, bringing the total number of employees to approximately 50. Transportation associated with the facility will continue to be via commercial truck, automobile, rail, and international ship.

Lead Agency:

Cowlitz County, as the SEPA lead agency for the proposal, has determined that it does not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030 (2) (c). This decision was made after review of a completed environmental checklist and other information on file with the lead agency. This information is available to the public upon request.




