Affected Facility	Tesoro Logistics Operations - Vancouver Terminal 2211 St. Francis Lane, Vancouver, WA 98666	
Description of Facility	Tesoro Logistics Operations LLC (Tesoro) operates a bulk gasoline terminal in Vancouver, WA. The terminal is located on property owned by the Port of Vancouver.	
Source Designation	<u>Minor</u> . The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for operation of a portable vapor combustion unit at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
