Affected Facility	Vancouver School District 1310 West 11 th Street Vancouver, WA 98660	
Description of Facility	BNSF Railway operates a railyard in Vancouver, WA	
Source Designation	<u>Minor</u> The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit modification for installing an emergency generator, incorporating small unit notifications to the existing permit, and removing units from the permit that are no longer on site. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information.	
Affected Pollutants	The proposed permitting action is expected to impact emissions of the following pollutants: Nitrogen Oxides (NO _x), Carbon Monoxide (CO), Volatile Organic Compounds (VOC), Sulfur Dioxide (SO ₂), Particulate Matter (PM), Hazardous Air Pollutants (HAPs) and Toxic Air Pollutants (TAPs)	
Public Comment Period	No public comment period for the draft permit is currently scheduled. A 30-day public comment period for the draft permit may be provided upon written request pursuant to SWCAA 400-171(1).
