Description of Facility	Puget Sound Energy operates a natural gas transfer and storage facility on Zandecki Road in Chehalis known as the Jackson Prairie Gas Storage Operation.
Source Designation	<u>Title V Opt-out.</u> This facility is a stationary source that would be subject to the Operating Permit Program if a federally enforceable emission limit was not in place. Facility emissions are limited to less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.
Purpose of Application	SWCAA has received a permit application for operation of multiple nonroad engines in support of temporary maintenance work at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information.
