RE: Revision to the SIP: Southwest Air Pollution Control Authority Regulations

On behalf of the Governor, I am submitting a revision of the State Implementation Plan (SIP) for the state of Washington. This revision consists of amended regulations SWAPCA 400, *General Regulations for Air Pollution Sources*; SWAPCA 476, *Standards for Asbestos Control, Demolition, and Renovation*; SWAPCA 490, *Emission Standards and Controls for Sources Emitting Volatile Organic Compounds*; SWAPCA 491, *Emission Standards and Controls for Sources Emitting Gasoline Vapors*; and SWAPCA 492, *Oxygenated Fuels*, from the Southwest Air Pollution Control Authority (SWAPCA) and are being submitted in their entirety. The amendments to SWAPCA 400, 490, 491, and 492 became effective on November 1, 1996. The amendments to SWAPCA 476 became effective on November 21, 1996.

Pursuant to RCW 70.94.141, the enclosed regulations affect the Southwest Washington Interstate Air Quality Control Region by the date indicated on the SIP Adoption Order. This submittal supersedes any previous submittal of SWAPCA regulations 400, 476, 490, 491, and 492. Upon approval, please place these regulations under Section 3 - Local Air Authority Regulations, in Section 3.SW - Southwest Air Pollution Control Authority, under Subsections 3.SW.400, 3.SW.476, 3.SW.490, 3.SW.491, and 3.SW.492, respectively.

Supporting documentation, two hard copies of the regulations, and one computer diskette of the regulations in Word Perfect 5.1 software are enclosed to meet administrative requirements for the SIP submittal. The diskette contains the adopted regulations in their entirety and is a true copy of the originals. The documentation includes the SIP Adoption Order, public hearing notices, and certifications of public hearing. A public hearing was held in Vancouver on November 19, 1996, after at least a thirty day public notice. No public comment was received during the comment period.

SIP ADOPTION

ORDER

The Washington State Department of Ecology held a public hearing, given on reasonable notice, to receive comments on the inclusion of amendments to regulations SWAPCA 400, *General Regulations for Air Pollution Sources*; SWAPCA 476, *Standards for Asbestos Control, Demolition, and Renovation*; SWAPCA 490, *Emission Standards and Controls for Sources Emitting Volatile Organic Compounds*; SWAPCA 491, *Emission Standards and Controls for Sources Emitting Gasoline Vapors*; and SWAPCA 492, *Oxygenated Fuels into the Washington State Implementation Plan*. No public comment was received at the hearing, and Ecology has met all relevant state and federal procedural requirements.

Therefore:

IT IS HEREBY ORDERED that the attached document, constituting revisions, are approved and adopted by the Department of Ecology as part of the Washington State Implementation Plan for implementing, maintaining, and enforcing National Ambient Air Quality Standards. All provisions of the Washington State Implementation Plan inconsistent with the attached documents are superseded.

## **SWAPCA Regulations Amendments Summary**

### **SWAPCA 400, *General Regulations for Air Pollution Sources***

- Sections -010, -020, -030, -040, -050, -052, -060, -070, -074, -075, and -076: Changes include new definitions, clarifications to wording, updating federal rule adoption dates, adopting additional federal rules, and providing reference to new sections for provisions regarding maintenance plan areas.
- Sections -101, -105, -107, 109, -110, -111, -112, -113, -114, -115, and -116: Establishes general emission requirements for all air pollution sources within SWAPCA jurisdiction. These requirements include permitting, monitoring, testing and reporting requirements. Changes include a new section to address requirements for a maintenance plan area, clarification to exemptions, reference to SEPA (WAC 197-11) and reference to recent federal changes.
- Sections -136, -171, -190, -230, -270, and -290: Establishes general emission requirements for all air pollution sources within SWAPCA jurisdiction. These requirements include permitting, monitoring, testing and reporting requirements. Changes incorporated include reference to the maintenance planning area, publication of preliminary approvals and reference to federal requirements for public information.

### **SWAPCA 476, *Standards for Asbestos Control, Demolition, and Renovation***

- Changes are intended to be clarifications to the existing regulation. New sections will clarify portions of the existing regulations and identify procedures now utilized by SWAPCA. They incorporate more details of federal requirements.

### **SWAPCA 490, *Emission Standards and Controls for Sources Emitting Volatile Organic Compounds***

- Changes include clarification to words, new definitions, applicability to address maintenance plan area, incorporation of federal requirements for gas tanker testing, and providing references to other applicable regulations.

### **SWAPCA 491, *Emission Standards and Controls for Sources Emitting Gasoline Vapors***

- Changes include clarification to existing language and definitions, removal of obsolete compliance dates, changes to Stage I throughput to be consistent with WAC 173-490 and provide reference to testing and reporting requirements, removing Skamania County from Stage II requirements, and increasing throughput for Cowlitz, Lewis, and Wahkiakum Counties to 1.2 million gallons.

### **SWAPCA 492, *Oxygenated Fuels***

- Revisions include applicability to refer to Clark County as a maintenance plan area for carbon monoxide (CO), clarification to definitions, and changes to control area for oxygenated fuels to trigger as provided in CO maintenance plan.
