7. Identify, if possible, whether the proposal may conflict with local, state, or federal laws or requirements for the protection of the environment.

There are no known conflicts with local, state or federal laws or requirements for the protection of the environment. Fees will still be applicable but will exist in a Consolidated Fee Schedule developed through a public process and adopted by the SWCAA Board of Directors.
